## Aug 16-27:

Online bill pay request from Jamie:

I would like to officially request that we (I) sign UUCM up for online bill pay for some of our accounts (Liberty, Eversource, Staples, etc.). This will ensure prompt payment of our bills, and would take some pressure off of the two signatories that we currently have.
